FROM SELÇUK UNIVERSITY RECTORATE

For the Thesis Master's and Doctoral Programs of our University's Institute of Health Sciences, students will be admitted to the following departments within the determined calendar in the Fall Semester of the 2023-2024 Academic Year.

APPLICATION CONDITIONS/DOCUMENTS

- 1. To apply for Thesis Master's Programs; To apply for undergraduate and doctoral programs, you must have a master's degree. Since the education period of the faculties of medicine, dentistry, veterinary medicine and pharmacy within the Higher Education Institutions (excluding preparatory classes) is at least 5 years (10 semesters), Article 16 (2) of the Postgraduate Education and Training Regulation published in the Official Gazette dated 20.04.2016 and numbered 29690.) In the article, those who have 10 semesters and duration of undergraduate education, excluding preparatory classes, are counted as master's degree. For this reason, graduates of the relevant faculty will be able to apply to doctoral programs.
- 2. Candidates who will apply for a master's program must choose a bachelor's degree, and candidates who will apply for a PhD program must choose a master's degree. Applications submitted with the wrong graduation type will not be processed.
- **3.** To have received at least 55 points from the ALES exam, from the type of score specified in the announcement of the program applied for. TUS and DUS exam results replace ALES, provided that they are not less than 50 (Fifty) points. ("TUS score: It is obtained by multiplying the standard score obtained from the Basic Medical Sciences Test-1 section by 0.7 and the standard score obtained from the Clinical Medical Sciences Test by 0.3.").
- **4.** Candidates who will apply to the doctoral program must have at least 55 points from YDS, E-YDS, YÖKDİL and TIPDİL in any of the languages English, German, French, Arabic, Italian, Spanish, Russian, Chinese, Japanese and Persian, or a score accepted by the ÖSYM board of directors. Must have received an equivalent score from an exam.
- **5.** Candidates who will apply to the PhD program with their TIPDİL exam score must have their exam result document approved by the Institution organizing the exam and submit it.
- **6.** Exam result documents of candidates who will apply to the PhD program with their TOEFL exam scores will be accepted after verification at the School of Foreign Languages of our University. TOEFL documents are valid for 2 years.
- **7.** The validity period of all exam result documents accepted in the application (except TOEFL document) is 5 (five) years from the exam date.
- 8. Non-thesis master's degree graduates cannot apply to doctoral programs. However; Only candidates who have graduated from non-thesis master's programs before 06/02/2013 can apply.
- **9.** A student cannot be enrolled in more than one thesis or non-thesis graduate program at the same time. However, one can be enrolled in a maximum of two different graduate programs at the same time, one with thesis / doctorate and one without thesis. The records of those who are found to have registered illegally will be deleted.
- **10.**Before applying, candidates should carefully examine the application/admission conditions and requested information/documents, enter information carefully during the on-line application, save it and print out the latest application. Applications that are not made in accordance with the rules specified in the Announcement Text are eliminated by the application system and deemed invalid. The applicant is responsible for any mistakes made during the application.

APPLICATION METHOD

- 1. Applications; It will be held online at http://ensbis.selcuk.edu.tr/OnBasvuru between 24 28 July 2023 (until 23:59).
- 2. Since verification cannot be made because any of the documents required for the application are not registered with YÖKSİS and ÖSYM, the applications of candidates in this situation will be made personally between 24-27 July 2023. (Candidates who will apply with any of the TOEFL, TIPDİL, TUS, DUS exam results and candidates who graduated from abroad whose equivalence is not displayed in YÖKSİS)
- **3.** ALES requirement is not required for applications to doctoral programs for graduates of doctoral degree / proficiency in art / specialization in medicine, dentistry, veterinary medicine and pharmacy (relevant documents must be submitted at the time of application). If these candidates do not have an ALES certificate, their ALES score is accepted as 60. Candidates who apply in this way must apply personally to the Institute Directorate with the documents required for pre-registration during working hours between 24 and 27 July 2023.
- **4.** While registering to the online application system, graduation information, YÖKSİS, ALES and foreign language score information will be automatically obtained from the ÖSYM system, and candidates whose graduation information cannot be returned by the system must apply to the higher education institution they graduated from. Registrations of those whose graduate and score information is missing or incorrect will be blocked by the system. In addition, candidates must complete their application using their undergraduate graduation information and score for the Master's program, and their Master's graduation information and score for the PhD program.
- **5.** The candidate photo (passport) to be uploaded to the system must be taken within the last six months and must be at least 250*300 pixels in size.

EVALUATION OF PRELIMINARY APPLICATIONS

- 1. After the application period expires; Firstly, the application system checks whether the application is valid/invalid. Invalid ones are not taken into preliminary evaluation. However, applications submitted with special requirements or graduation from a different department will be evaluated by the relevant department. The applications of candidates who are not accepted by the department, who do not comply with special conditions, or whose applications for graduation from different departments are rejected, will be deemed invalid.
- 2. Secondly, the system calculates whether the candidates whose Preliminary Applications are accepted are eligible to take the written science exam.
- 3. Postgraduate programs must take written science exams; The ranking is made by taking 50% of the ALES score + 25% of the undergraduate graduation GPA and starting from the highest score. Candidates up to 4 (four) times the announced quota are entitled to take the written science exam.
- 4. Doctoral programs must take written science exams; The ranking is made starting from the highest score by taking 50% of the ALES score + 25% of the undergraduate GPA (graduates of the Faculties of Medicine, Dentistry, Veterinary Medicine) or master's degree graduation GPA. Candidates up to 4 (four) times the announced quota are entitled to take the written science exam.
- 5. Candidates who have the right to take the written science exam; They will obtain their Exam Entry Documents from the "Application Control" link in the on-line application system, starting from 17:00 on August 4, 2023. Candidates who will take the exam are required to come to the exam with their exam entry document and Republic of Turkey ID card, identity card or driver's license or passport document that replaces the ID card. Written science exams for candidates applying to doctoral and master's programs will be held on Tuesday, August 8, 2023, at 10:00 in the faculties to which the relevant department is affiliated.

EVALUATION OF WRITTEN SCIENCE EXAM RESULTS

For admission to master's programs, the highest score is 2.40 (62.66 in the hundred percent system) according to the success grades determined by taking the sum of 50% of the ALES score, 25% of the undergraduate weighted graduation grade average and 25% of the written science exam score. Starting from the candidate who gets the score, they are entitled to enroll in the program they applied for according to the announced quota. In case of equality in the rankings, priority is given to the candidate with a higher undergraduate GPA.

For admission to doctoral programs, 50% of the ALES score, 25% of the registered science exam score of those who are not registered or who apply with a master's degree from medicine, dentistry and veterinary faculties, and the total of the registered science exam score is at least 2.50 according to their success grades. Applications starting from the candidate with the highest score, provided that they receive a score of 65.00 (one-hundred system), are entitled to enroll in the program according to the announced quota. In the ranking, shine is given to the higher ones who are not given a master's degree in freedom.

Candidates who cannot get at least 50 points in the written science exam for PhD and Master's programs or those who do not take these exams will be considered unsuccessful and will not be evaluated.

Objections to exam results must be made within three business days from the day the exam results are announced.

Announcement of Results: It will be announced on our Institute's website as of August 11, 2023. Final Registration Date: It will be done between 14 - 17 August 2023, only via e-mail at sagbil.kayit@selcuk.edu.tr. (Registration requests of candidates who do not register on the specified dates will be deemed invalid.)

Reserve Registration Date: It will be announced on August 23, 2023, if there are candidates who have the right to reserve registration.

- 2. For non-thesis Master's and Master's programs, a certified copy of the Undergraduate Graduation Certificate or a barcoded copy obtained from E-Government.
- 3. For doctoral programs, a certified copy of the Undergraduate and Master's Graduation Certificates or a barcoded copy obtained from E-Government.
- 4. Approved transcripts of Undergraduate and Master's degrees for non-thesis Master's and Master's degree candidates, and Undergraduate and Master's Degree transcripts for PhD candidates.
- 5. ALES Result Certificate.
- 6. Foreign Language Exam Result Certificate
- 7. Photocopy of the Republic of Turkey ID card
- 8. Military status certificate for male students (Can be obtained from e-government, with new date and barcode.
- 9. 2 (two) passport size photographs.

IMPORTANT REMINDERS

- 1. A scientific preparation program can be applied to the declared departments, in accordance with the Selçuk University Postgraduate Education and Training Regulation, for those who have received their bachelor's and/or master's degree from a different branch or the equivalent from a higher education institution other than the university.
- **2.** Even if they pass the exam and register, the registrations of students whose documents are missing or who are understood to have registered with inappropriate documents will be deleted.
- **3.** Those who will apply to our postgraduate education programs with diplomas received from universities abroad are required to submit a certificate of recognition from YÖK for programs that do not require clinical practice, other than health fields, and an equivalence certificate from YÖK for programs with clinical practice.
- **4.** Graduation weighted grade point averages of the candidates who graduated according to the quadrature system will be evaluated by converting them to the hundredth system by the system according to the comparison table published on the website of the Council of Higher Education.
- **5.** A candidate who cancels his/her application after submitting his preliminary application online through the system will not be able to apply to the same department again.
