# Selçuk University Graduate Education Institutes Award Directive FIRST PART

Purpose, Scope, Basis, Definitions and Abbreviations

#### Aim:

**ARTICLE 1-** The purpose of this directive is to encourage students studying at institutes providing postgraduate education within Selçuk University to do qualified studies and contribute more to science and society.

### Scope:

**ARTICLE 2-** This directive covers the awards to be given by the institutes providing postgraduate education within Selçuk University and the procedures and principles regarding the granting of these awards.

#### **Rest:**

**ARTICLE 3-** This directive has been prepared based on paragraph c) of Article 4 of Law No. 2547 dated 4.11.1981.

# Definitions and Abbreviations:

**ARTICLE 4-** In this directive;

- a) AHCI; Arts and Humanities Citation Index
- b) Institute; Institutes providing postgraduate education within Selçuk University (Educational Sciences, Natural Sciences, Mevlana Researches, Health Sciences, Seljuk Studies, Social Sciences, Turkic Studies Institutes),
- c) ESCI: Emerging Sources Citation Index
- *d)* Student; Master's and doctoral students with thesis who continue their education/graduated from institutes providing postgraduate education within Selçuk University,
- e) Rector; Rector of Selçuk University,

- h) SCIE; Expanded Science Citation Index (Expanded),

#### **SECOND PART**

Awards, General Provisions, Presentation of Awards and Cases Without Provisions

#### Awards:

- **ARTICLE 5- (1)** Within the scope of this directive, taking into account the scientific studies carried out by students who graduated from the institutes providing postgraduate education within Selçuk University;
- a) Most Successful Doctoral Thesis Award,
- b) First Prize,
- c) Thesis Publication Award,
- **d**) Appreciation Award,
- e) Project Award,
- f) Patent Award,
- g) Honor Award,
- (2) A gift and/or document/plaque determined by the Institute Board of Directors will be given as an award.

# Most Successful Doctoral Thesis Award:

**ARTICLE 6- (1)** The Most Successful Doctoral Thesis Award is given separately for the fields of Science, Health and Social sciences.

(2) The Most Successful Doctoral Thesis Award is given by taking into account the total score received by the student from the scientific studies produced from the doctoral thesis, in which the student is the first author and the advisor, given in the table below.

- (2) No reduction multiplier is applied in calculating points.
- (3) In order to apply for the Most Successful Doctoral Thesis Award, it is necessary to complete a scientific study of at least 100 points.
- (4) The Most Successful Doctoral Thesis Award is given to the student who gets the highest score according to the above scoring.

#### First Prize:

**ARTICLE 7- (1)** The First Prize is given separately to each thesis master's and doctoral student who has the highest grade point average in the scientific fields determined by the Institute Board of Directors, among the students graduating from each of the institutes providing postgraduate education within Selçuk University.

(2) In case of equal GPA, First Prize; It is given to the student who has more course credits, taking into account the duration of education.

# Thesis Publication Award:

**ARTICLE 8-** Produced from a master's or doctoral thesis, published in journals within the scope of SCI, SCIE for science and health sciences and with Q1 and Q2 quarters; Thesis Publication Award is given to graduates who have one research article published in journals within the scope of SSCI, AHCI, ESCI for social sciences.

# Appreciation Award:

**ARTICLE 9-** The Appreciation Award is given to students who have received awards with their oral/poster presentations from scientific events they attended, such as qualified national, international congresses and symposiums related to their field.

# **Project Award:**

**ARTICLE 10-** Project Award is the award for working as an executive or researcher in a project supported and completed by TUBITAK, SAYEM, international cooperation, Development Agencies and similar national or international private or official institutions and organizations during your postgraduate education (master's degree with thesis and doctorate degrees are evaluated separately). It is given to students who take it.

#### Patent Award:

**ARTICLE 11-** Patent Award is given to the student and faculty member who obtained a patent registered by authorized institutions and organizations related to the field of science during his postgraduate education.

Regarding the same patent, an application can be made only once and for one student.

#### Honor Award:

**ARTICLE 12-** The Honorary Award is given upon the application of the faculty member who supervises the student who is entitled to receive the Most Successful Doctoral Thesis Award or Thesis Publication Award.

# General provisions:

**ARTICLE 13- (1)** Applications for all awards must be made within the date range determined by the Boards of Directors of the institutes providing postgraduate education.

- (2) Applications for each award must be made using the forms published on the websites of the institutes providing postgraduate education.
- (3) Applications for the First Place, Appreciation and Project awards cover the relevant academic year in which the award will be given.
- (4) Applications for thesis publication, Most Successful Doctoral Thesis Award and Honor Award can also be made within 3 (years) following graduation. Applications made after 3 (three) years following graduation will not be evaluated.
- (5) Proof documents regarding the scientific studies declared during the application must be attached to the application form. For publications that have not been published, the DOI number of the relevant publications must be obtained and be available digitally.
- **(6)** After the award application process is completed, applications of graduating students will be evaluated in the next semester.
- (7) Students who have received disciplinary punishment cannot apply for the awards mentioned in this Directive; if it is later determined that they have received disciplinary punishment, the award given will be cancelled
- (8) Award winners are given their awards at the Graduate Graduation Ceremony. Ödüllerin Verilmesi ve Takdimi:

**ARTICLE 14-** Awards are presented to the individuals themselves or their representatives at the graduation ceremony to be held on a date determined by the institute(s) providing postgraduate education.

Matters for which there is no provision:

**ARTICLE 15-** For matters not included in this directive, the provisions determined by the relevant Institute Board of Directors apply..

#### THIRD PART

Enforcement and Execution

#### Force:

**ARTICLE 16-** This directive enters into force as of the date it is accepted by the Selçuk University Senate.

#### **Executive:**

**ARTICLE 17-** This directive is carried out by the Rector of Selçuk University.
